1.1. Vision for the Cavan Local Development Strategy;

To develop sustainable rural communities throughout County Cavan, through the provision of a programme that will enhance the social, natural, human, physical and financial resources available to individuals and communities and thereby make Cavan 2027 a place that we can be proud of, a place where people can have a good quality of life; a better place to live, work and to enjoy.

1.2. Overview

It is vital that the needs of communities are met in a sustainable way. Development must protect the natural rural environment while supporting community, society and the economy in Cavan to thrive. The strategic actions identified in this Local Development Strategy (LDS) will sustain and regenerate rural areas, build community capacity, invest in rural services and enterprises while protecting the environmental integrity of the landscape.

In developing its Local Development Strategy for 2023-2027, Cavan LEADER LAG group has been keen to ensure meaningful engagement with communities across Cavan and with community stakeholders able to offer useful opinions and perspectives based on the priorities and needs in the local area. Findings are based on the experiences of local residents and key stakeholders at community level. The public consultation process was designed to ensure maximum participation from residents and stakeholders within County Cavan, therefore a variety of mediums were used, and meaningful 'in-person' engagement was prioritised. This gave participants the opportunity to speak directly to the consultation management team. The public consultation opened on 17th April 2023 and closed on 17th May 2023. The consultation encompassed public consultation meetings across the county, focus group meetings with key groups of stakeholders and an online survey. An open morning was also held, and written submissions were welcomed and accepted. In total 147 individuals engaged in-person in the Local Development Strategy consultation and 135 engaged online. Two written submissions were received. In total, 284 participants engaged with the LDS Consultation over the course of one month.

The Department of Community and Rural Development approved €4,800,000 of support for LEADER projects in county Cavan on the basis of the Cavan Local Development Strategy 2023 - 2027. The following pages describes the key themes/local objectives and strategic actions with the allocated budgets.
