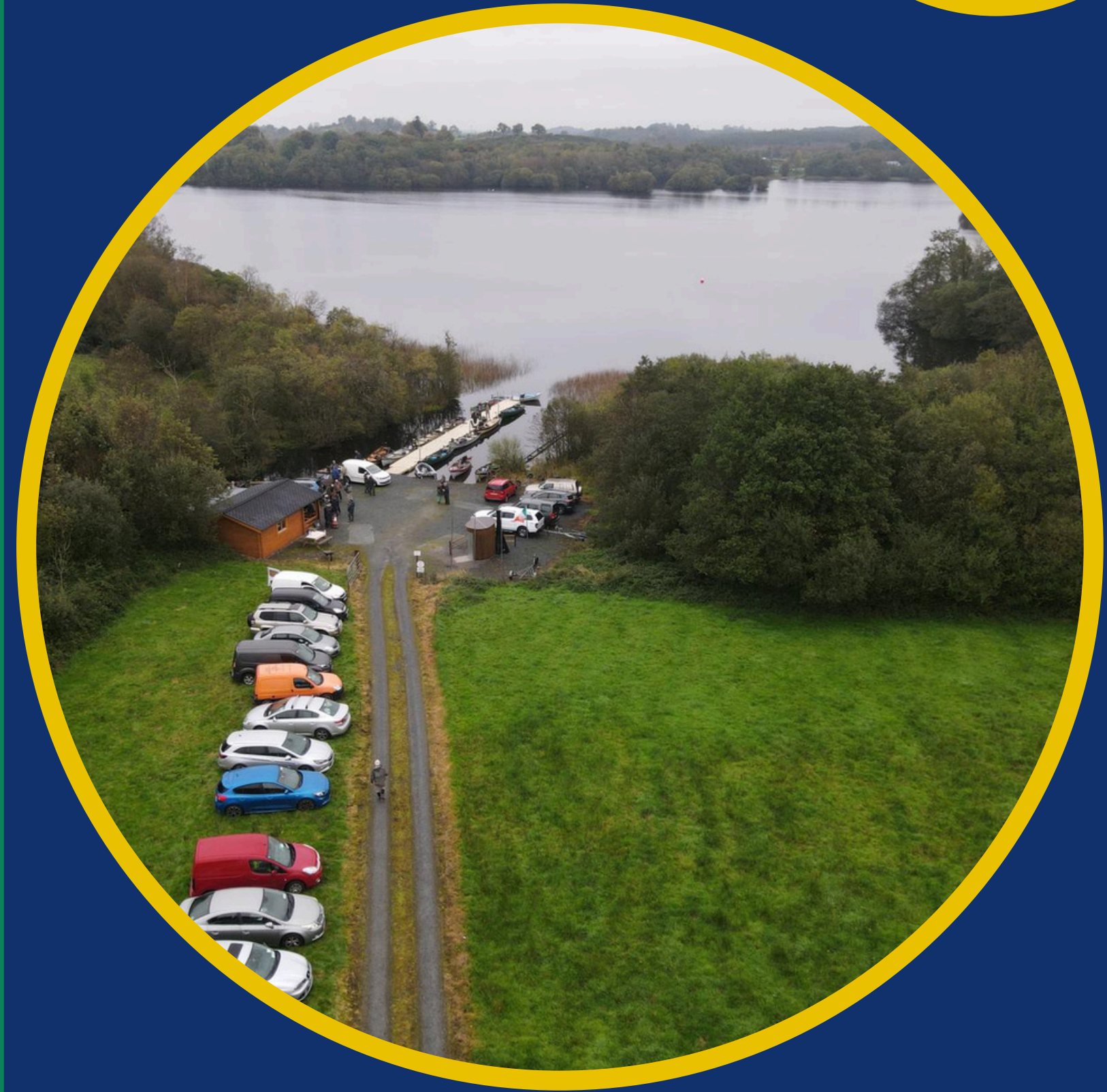

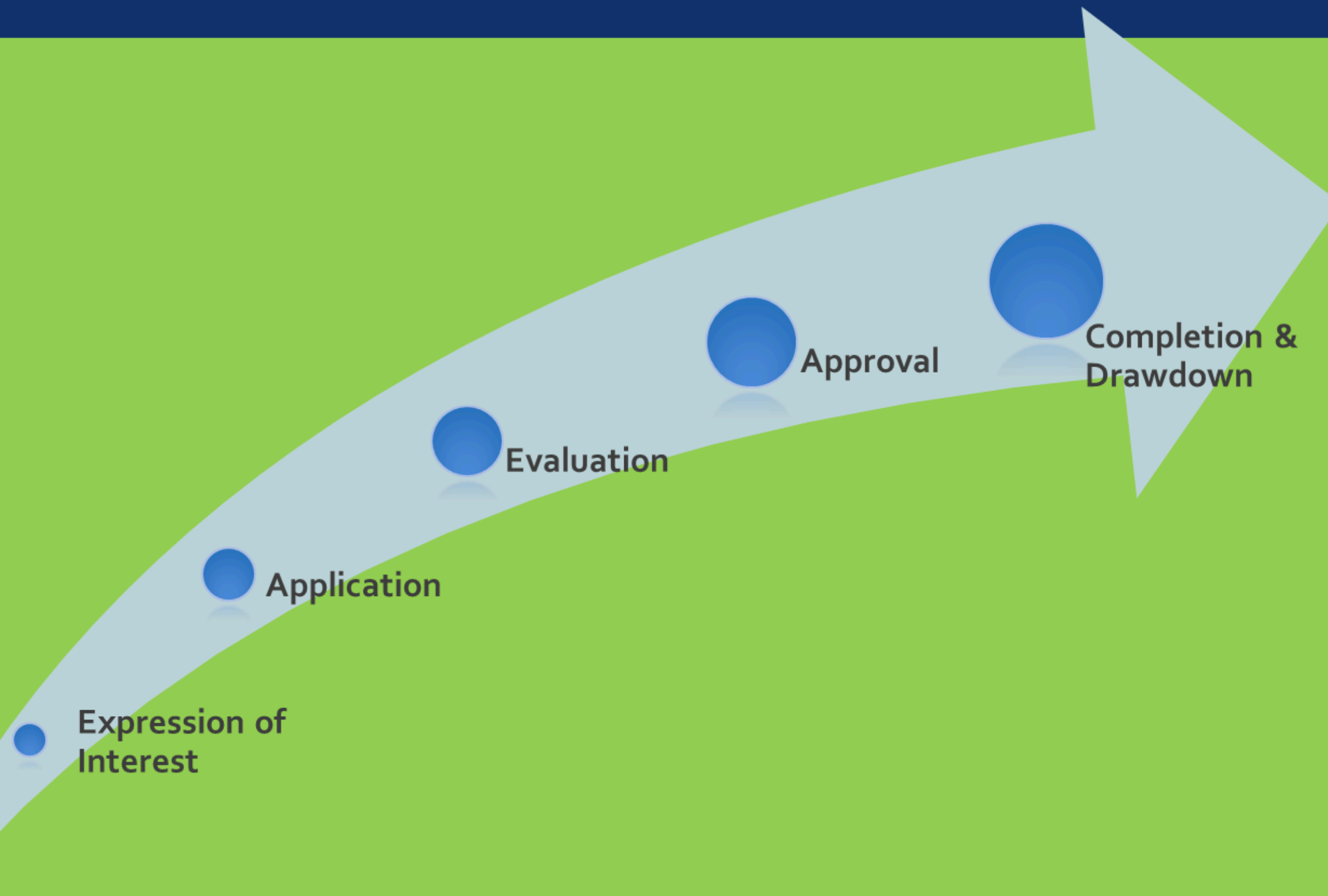

HOW TO APPLY FOR CAVAN LEADER FUNDING?

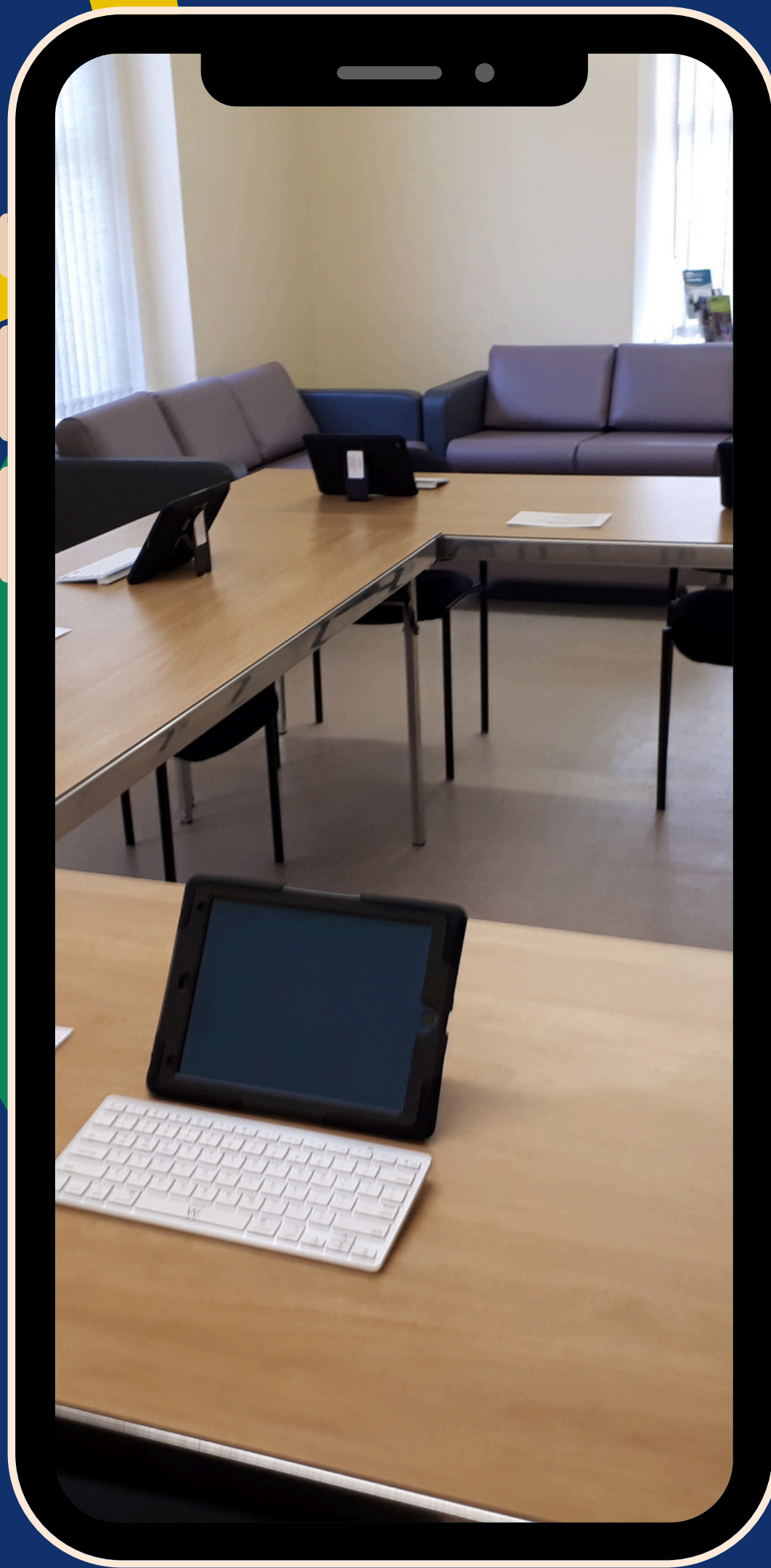
- Download 'Expression of Interest' (EOI) form (QR code)
- **FULLY** complete 'Expression of Interest' (EOI) form & submit
- EOI's will be reviewed by CCLD staff & will determine if your project proposal is eligible (with LEADER operating rules & Cavan LDS)
- Note that one EOI needs to be completed for each project proposal
- Note EOI's are NOT an application form



HOW TO APPLY FOR CAVAN LEADER FUNDING?



- If eligible, you will be provided with **application pack** & CCLD staff will provide support
- FULLY complete application form & submit with all documentation
 - Examples of some **required** application document:
 - Financial details – bank statements, annual accounts, evidence of loans
 - Ownership/Title/Leases/Agreements (stamped & certified with maps)
 - Insurance policy details – for all parties
 - eTax clearance certificates – for all parties involved with project
 - Quotations/Procurement
- CCLD LEADER staff are available to assist you with your application form



WHAT IS ELIGIBLE



Actions which link to the LEADER themes, are included in the local development strategy for county Cavan and comply with the LEADER Operating Rules will be eligible for consideration for LEADER funding.

SOME INELIGIBLE SECTORS & ACTIVITIES

- primary Agriculture
- conventional retail operations
- planning application fee / reclaimable VAT / insurance fee
- improvements/refurbishment of private residential property
- courses or training which form part of the normal education programmes
- schools & childcare
- vehicles
- operational costs
- bed and breakfasts

TARGETED CALL – THEME 2: OBJECTIVES FOR RURAL INFRASTRUCTURE AND SOCIAL INCLUSION

Call for communities to build or upgrade community recreational or physical amenities on the grounds of sporting organisations in order to adequately serve the needs of local rural communities (particularly the needs of children, teenagers, older people and new communities).
Economy

Budget for the Call: €500,000

Maximum – Up to €75,000 per project

Minimum – €5,000.00 per project

Maximum rate of grant aid: 75%

Qualifying Criteria;

- Mainstream sporting activities are not eligible
- Non-commercial projects only
- Community/Voluntary group applicants only
- Social Inclusion policy required

Call opens for EOIs beginning of September, 2024 – Call closes beginning of October, 2024
